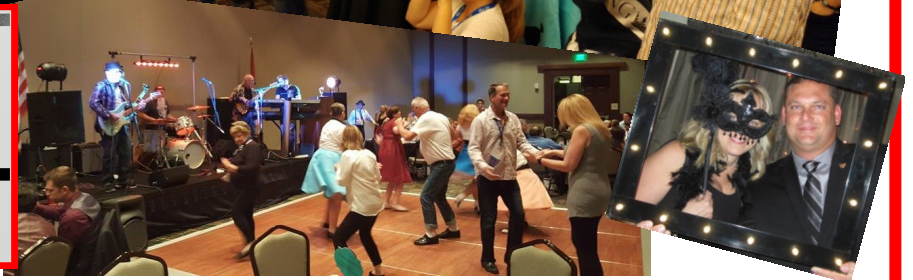

Dear Fellow FAPPS members,

As required by Article VIII Section 7 of our by-laws the below you will find; (a). a description of the motion or amendment, (b). the result of the vote and (c). the final wording of the order or amendment if passed that were made at our board meeting held December 2, 2017:



- Bob Musser moved that a new Policy & Procedure be written that the President will be responsible to schedule all board meetings one year in advance and will work with the Administrator to schedule and book all board meetings. Seconded by Lance Randall. Motion carries unanimously.

13.1 The President will be responsible (working with the Administrator) for selecting dates and locations for all regular board meetings one year in advance. This includes setting dates and locations for meetings that will occur past the end of his or her term.

- Lance Randall moved that a policy be created that when an attendee register for an education class that the book will be available to print online from the FAPPS website at no additional charge. The attendee is required to bring the book to the class with them in print or pdf format; or the attendee will be required to purchase a book at the class for a cost of \$20.00. Seconded by Bob Musser. After much discussion, Bob Musser moved to Amend the Motion to include print or pdf format. Second by Chris Yeoman. The motion passes 5-2.

In preparation for our annual conference in March, note your calendar that the final deadline for submitting any proposed Bylaw amendments for consideration is **January 9, 2018**.

On a final note, the next FAPPS 27th Annual Conference will be March 9-11, 2018 at the Orlando Marriott Lake Mary, 1501 International Parkway, Lake Mary, FL. I hope to see you there!

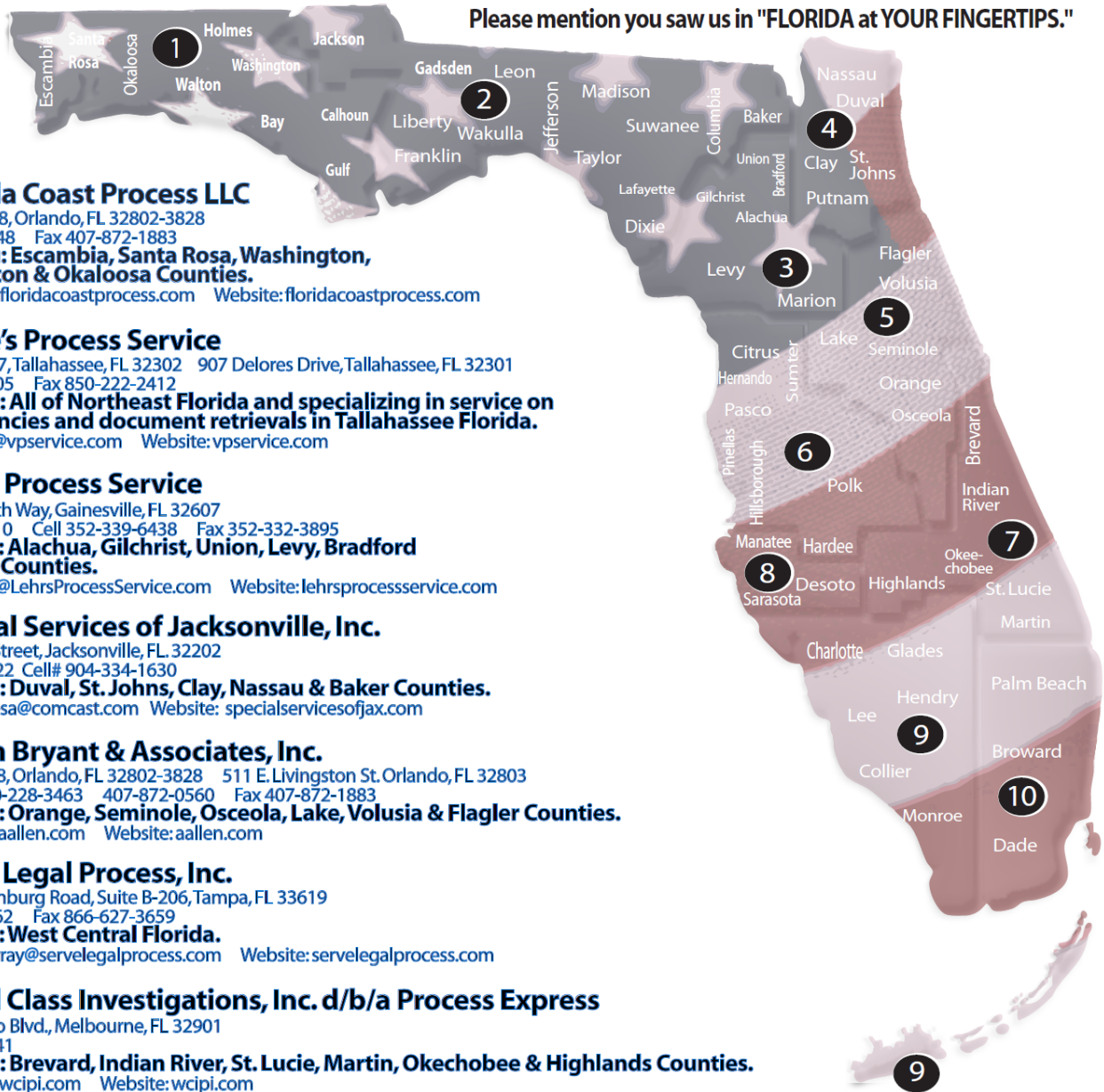

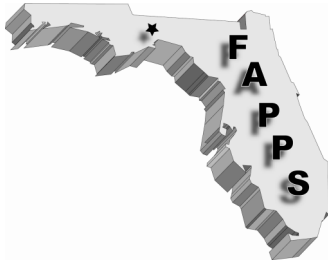

It's not too early to be thinking about what you can do for your Association.

In 2018, we'll be electing the entire slate of Officers and Directors.

To run for office, you need to have been a member in good standing for the previous 12 months (at the time of the election).

To run for President or Vice-President, you need to have been a board member in any position for at least one of the preceding five terms.

To recap our election procedure:

In 2003, the FAPPS Board enacted changes in the Policy and Procedure Manual and established an Election Committee (EC) to ensure that our election procedure is fair, smooth, and efficient.

The goals for changing these procedures were these:

- To ensure that candidates have sufficient time to think through what it means to be a leader of FAPPS and to allow them to put their thoughts in writing.
- To streamline the procedure so that nominations and the election itself do not take over the entire convention.
- To allow the members sufficient time to find out who is running, read their position papers, and make informed, considered, intelligent decisions on who they want to lead FAPPS.



Nominations will be accepted in writing (paper or email is fine) by the Election Committee (EC). The nomination window for 2018 is from January 2, 2018 through March 1, 2018 5:00 pm EST. There will NOT be an additional nomination window at the annual convention itself.

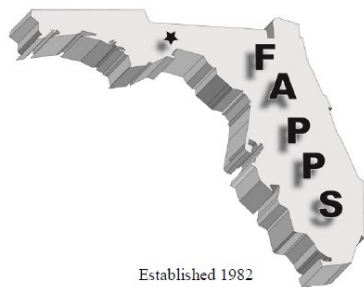
The EC will verify that the nominee is eligible to hold office and ask the nominee to Accept or Decline the nomination.

The EC will ask that each Nominee furnish a one page "position paper" as early as possible in the election cycle. These position papers will be published on the FAPPS website on a weekly basis. All position papers will then be gathered into a handout to be distributed to the members during convention registration. This will allow sufficient time to review, ask questions of the candidates in person to better make a decision about the leaders they are about to elect.

Nominees, their acceptance or decline status, and their position papers will be kept up to date on the FAPPS website.

Once the Nomination Period is open, please send your nominations via email to the **Election Committee Chair, Bob Musser**, at BobM@dbsinfo.com and be sure to include the nominee's name, the position nominated, and if you know it, the nominee's email address. As Nominations are made and accepted, you'll be able to check the status anytime on the FAPPS website at www.fapps.org/elections.

In response to member inquiries about the recent Supreme Court Ruling in Georgia, Paul K. Tamaroff, President provided the following information regarding the status of service in Georgia.

At this point I do not see how the ruling of our Supreme Court affects the ability to serve Florida papers in Georgia. The sheriffs have prevented certified process servers from serving Georgia papers since the certification program began. So, in effect, the Supreme Court ruling does not change the long-established practice of serving out-of-state papers. Additionally, when this issue arose I reached agreement with Sheriff Association Executive Director Terry Norris that the sheriffs' position would not affect the service of out-of-state papers. In other words, the sheriffs were not interested in attempting to prohibit the service of out-of-state papers under the statute. So, inasmuch as the law specifically provides that a certified process server may serve process anywhere in the State of Georgia; and because the Sheriffs are interested only in regulating Georgia service, and have specifically exempted foreign service from their "ban", the answer to your question is that the Court ruling does not affect Florida's ability to serve Florida papers in Georgia.

We will be scheduling a full GAPPS membership meeting, along with a meeting of our Board of Directors, to fully air what we believe to be our options. I will also be contacting the Chairman of the Georgia House Judiciary Committee to ask his opinion of where we might go from here. He has helped GAPPS thru our lobbying efforts to get the present law placed into effect. The 2018 legislative session begins in January. Lobbying, as you know, is quite expensive and it would be a stretch to come up with funds for a lobbyist. Our lobbyist charged \$35,000 for each legislative session, and that was a discount. He is also the lead lobbyist for the Georgia Bar. At this time, that much money might be a "bridge to far".

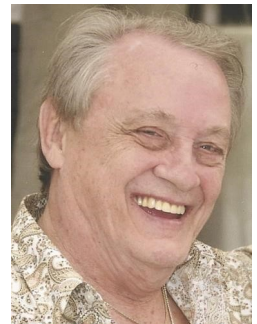

Charles "Chuck" Taylor died peacefully in Miami, Florida on December 10 at the age of 77. Chuck was born on August 30, 1940 in Scranton, PA to Charles and Mildred Taylor. Learning from Serving

An Educational Forum

Visiting the Archives of “Ask the Doctor” and “Learning from Serving” and FAPPS Education – The Beginning



FAPPS Education, in the 2000-2001 time frame, had little structure and was crammed into 15-30 minutes of an already more than full ONE DAY ANNUAL CONFERENCE.

In late 2001, the Board decided to expand the Conference into a TWO DAY affair (Friday and Saturday), allocating the last two hours after lunch Saturday to a new STRUCTURED education effort.

The new effort focused on the belief that FAPPS membership has a vast pool of “expertise” in everything from Process Serving, Private Investigating, legal issues and widely differing experiences in life. Drawing on this source would not only share experience, but facilitate networking as members listened to other member’s “expertise”.

Thus helping to break the “log-jam” of meeting/talking to folks you didn’t really know. An obvious benefit would be a stronger bonding of professionals, thereby strengthening FAPPS as an organization.

The FIRST TWO DAY Annual Conference

During the newly expanded TWO DAY ANNUAL CONFERENCE in 2002, the Education Committee Chairman moderated a full membership discussion.

The moderate discussions aimed at triggering maximum participation by focusing on actual process serving experiences. Topics were broken into about 10 -15 minute segments – or until we ran out of “stories”.

Topics were along the following lines:

- *Your funniest Serve*
- *Most difficult Serve*
- *Most interesting Serve*
- *Most “enjoyable” Serve*
- *Easiest Serve*
- *Most unusual Serve*

It was educational. Individuals came out of their “shy shell” and it was fun. It was also a learning experience for all and a lot more fun than “getting talked at”.

“Ask the Doctor” retires

A direct result of the “interactive” membership focused education session at the 2002 Conference, was a modification of the on-going column titled “Ask the Doctor”. This column, which was several years old, had addressed Process Serving questions submitted by members. In the October 2002 issue of Paper Chase, Jake Henderson, D & H Professional Investigation’s Process Serving story, from the 2002 conference, was published. Subsequently the “Ask the Doctor” column became “LEARNING FROM SERVING”, as each issue of the Paper Chase included a Process Serving “adventure”, provided by one of our members.

For the foreseeable future, Process Serving articles from the past will be published. Some names you may recognize, other are no longer in the business or are no longer with us. Nonetheless, the validity of the experiences remains, as we seek to learn from each other and those that preceded us.

An individual had been avoiding being served for two (2) months. He refused to come to the door or answer when anyone in the house was called. At least three different servers had attempted to serve him. Surveillance had also been used, but the individual did not come out of the house nor did he go anywhere in the house or garage where he could be seen, positively identified and therefore served.

Finally, the "boss" Process Server decided to "outwit" the "avoider", who like most non-servers are not fully aware of what constitutes a good or bad Serve. Jake arrived at the individual's home, went to the garage door, which was always half open. Jake, who was sure he was in the house, called the individual by name, stated HE HAD BEEN SEEN AND HE WAS NOW SERVED. The process was then affixed (posted) to the door.

The next day, Jake drove back to the "avoider's" house, and low and behold, he was outside cutting his grass. The "avoider" had assumed that the posting was a valid serve and he no longer had to hide. JAKE WALKED UP, CALLED HIM BY NAME AND SERVED HIM. After a brief, but friendly conversation, the "avoider" admitted his evasiveness had caused him more inconvenience than the effort had been worth.

This tactic, according to Jake, has been used successfully in several other cases involving subjects seeking to evade and avoid being served.

Jake it was a GREAT STORY and remains a GREAT SERVE, proving "a Good Process Servers is ALWAYS THINKING!"
